Bylaw No. 351/01

A BYLAW OF THE TOWN OF CARNDUFF TO PROHIBIT SMOKING IN CERTAIN PUBLIC PLACES.

The Council of the Town of Carnduff in the Province of Saskatchewan, hereby enact as follows:

1. INTERPRETION

In this Bylaw:

"Smoke" or "Smoking" means the lighting, carrying or smoking of any lighted cigar, cigarette, pipe or other smoking device.

"Private Social Functions" means an event for which the facility has been rented or reserved.

2. No person shall smoke in any of the following public places; (except in a designated smoking area established in accordance with Section 5 of this bylaw.

- a. Carnduff Centennial Arena
- b. Carnduff Curling Rink
- c. Carnduff Ball Diamonds
- d. Carnduff Town Hall Building
- e. Carnduff Swimming Pool

3. A "No Smoking" sign(s) shall be posed in appropriate locations in each facility and shall state:

- a. the phrase "No Smoking", or
- b. a graphic symbol substantially in the form shown on Appendix A, attached hereto, which shall be a minimum of 9cm x 11cm, and may include
- c. the words "Town of Carnduff Bylaw No. 351-2001" Maximum Penalty \$2,000.00".

4. A designated smoking area sign shall be posted in the designated smoking area and shall state:

- a. "Smoking In This Area Only" or
- b. words or graphic symbols substantially in the form shown on Appendix B, attached hereto, which shall be a minimum of 9cm x 11cm

5. Designated Smoking Area

- a. The public facilities listed in Section 2, may have one or more smoking areas designated in the premises, by posting in those areas a designated smoking area sign, and such area shall be designated by resolution of Council.
- b. Council may by resolution designate the size of the designated smoking area.
- c. An area may be designated as a smoking area if the area is equipped with a ventilation system that is separate from the ventilation system of the rest of the building and is vented directly to the outdoors.


6. A person at a private social function who carries or has in his possession a lighted cigarette or cigar or a pipe containing burning tobacco is exempt from Section 2 and does not contravene Section 2 of this Bylaw.

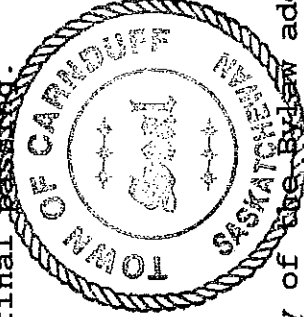
7. Offence and Penalties


- a. Any person who smokes within an area set out in Section 2 and not within a "Smoking Area" designated pursuant to Section 5 is guilty of an offence against this bylaw.
- b. Any person who is guilty of an offence against any provision of this bylaw shall be liable on summary conviction to a fine of not more than two thousand (\$2,000.00) Dollars in the case of an individual.

8. General Provision


- a. This bylaw may be cited as the Town of Carnduff Smoking Bylaw No. 351-2001.
- b. A decision of a court that one or more of the provisions of the bylaw are declared invalid in whole or in part does not effect the validity, effectiveness or enforceability of the other provisions or parts of the provisions of this bylaw.
- c. Once finally adopted this bylaw shall come into force on the date of final passing.

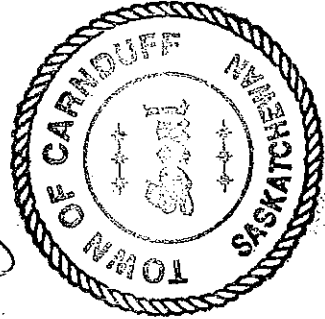

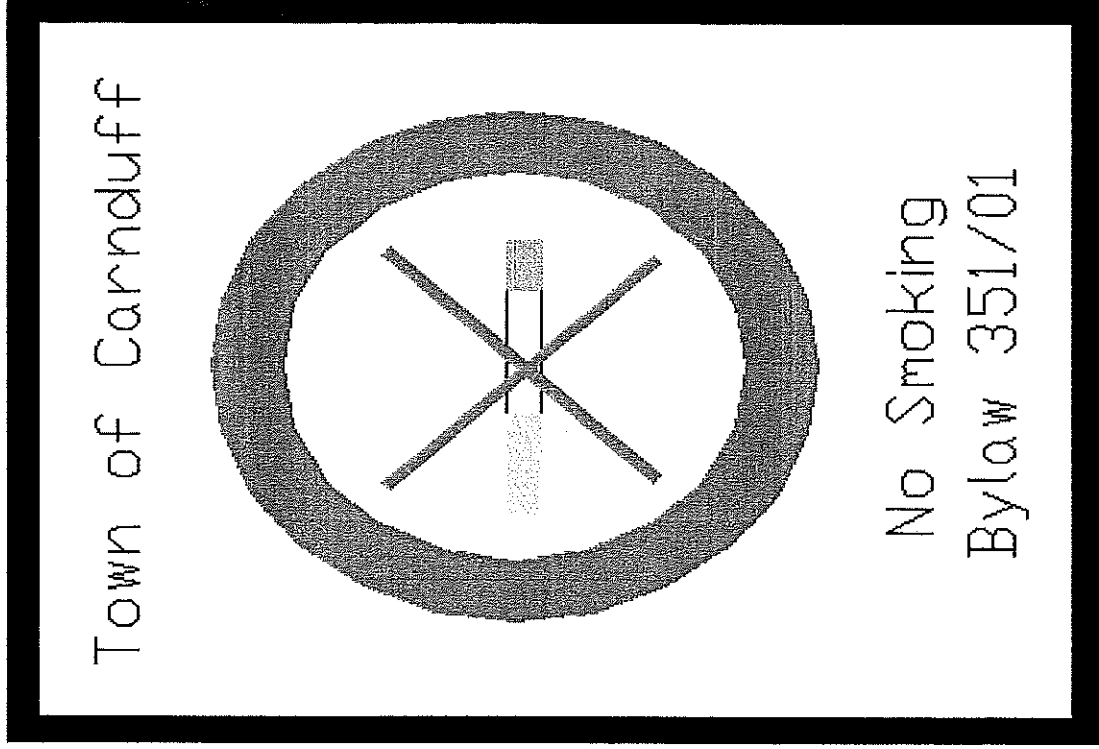

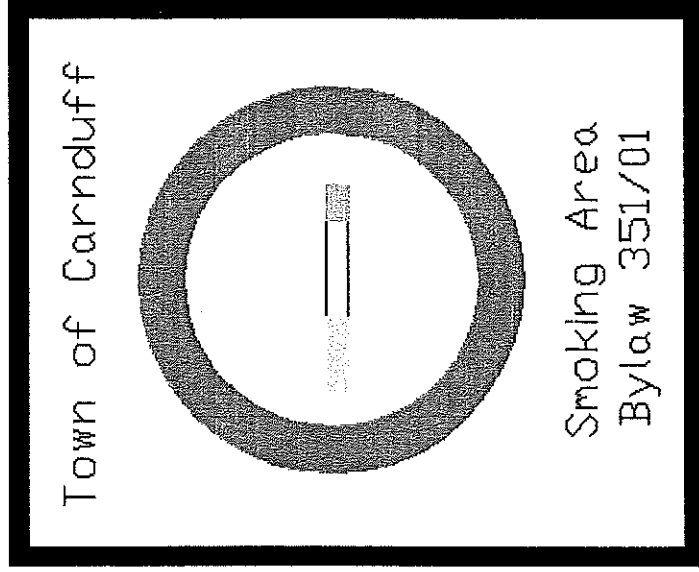
