By-Law 2236-19 City of Winkler

Being a By-law of the City of Winkler

To Amend Smoking By-Law No. 2215-18

Being a By-law under "The Municipal Act" and "The Non-Smokers Health Protection and Vapour Products Act" to regulate smoking within the City of Winkler. The Council of the City of Winkler in meeting duly assembled enacts as follows;

1. By-Law Name

This By-law may be referred to as the "Smoking By-Law".

2. Definitions

Unless otherwise expressly provided, or unless the context otherwise requires, words and expressions in this By-law have the same meaning as the words and expressions in "The Non-Smokers Health Protection and Vapour Products Act" of Manitoba.

- a) "City" means City of Winkler;
- b) "Municipal Public Building" means all City owned buildings;
- c) "Outdoor Seating Area" means an outdoor area or structure commonly referred to as a patio, deck, terrace, or rooftop, whether enclosed or not, that is open to the public or to which the public is customarily admitted or invited that is operated as part of a restaurant or licensed premises;
- d) "Smoke" or "Smoking" means to inhale, exhale, burn, carry or control a lighted cigarette, cigar, pipe, or similar equipment that burns any substance, including cannabis, or generates smoke, and includes the use of a hookah pipe, water pipe or bong;
- e) "Vape" or "Vaping" means the use of an electronic cigarette, vaporizer, or any other heated smoking equipment used to vaporize any substance whether or not it contains nicotine;
- f) "Vape Retail Store" means a fully enclosed premises where the sole function of the premises is the sale of electronic cigarettes, vaporizers, and other heated smoking equipment;

3. Outdoor Seating Area

- a) No person shall smoke or vape in any outdoor seating area
 - i. The owner of any area to which section 3(a) applies must ensure that signs indicating smoking and vaping are prohibited are displayed in a conspicuous location at all entrances to the outdoor seating area;
 - ii. The absence of a sign required in section 3(a)(i) does not relieve any person from compliance of this By-law;
 - iii. No owner shall permit smoking or vaping in any outdoor seating area;

4. Public Places

No person shall smoke or vape:

a) Within 15 meters outside of any doorway, window, or air intake of an enclosed Municipal Public Building;

- b) Within 15 metres of swimming pools, wading pools, spray pads or spray parks downed or operated by the City of Winkler.
- c) In any enclosed public place;
- d) In a transit shelter or bus stop;
- e) Inside a motor vehicle or equipment owned or leased by the City.
- f) Within 15 metres of athletic fields or hockey rinks owned or operated by the City of Winkler, during a youth event.
- g) On playgrounds and skate parks owned or operated by the City of Winkler.

5. Exception

Nothing in this By-law prohibits a person from vaping for the sole purpose of testing the device, or sampling products used with the device, prior to purchase within a vape retail store.

6. Cannabis

The consumption of cannabis is not permitted in any indoor and outdoor public spaces under The Non-Smokers Health Protection And Vapour Products Amendment Act.

7. Offence

- a) Any person who contravenes any provision of this By-law shall pay the administrative penalty outlined in Schedule A of the Enabling By-law No. 2174-17 or request a review by a screening officer in accordance with Part II of said by-law.
- b) That the amount of the administrative penalties set out in Schedule "A" to Enabling By-Law No. 2174-17 may be amended from time to time by resolution of Council.

8. Enforcement

For the purpose of enforcement of this By-law, the following persons are designated officers:

- a) Any member of the Winkler Police Service;
- b) City of Winkler By-Law Enforcement Officer

9. Repeal

THAT By-Law No. 1776-03 is hereby repealed
